## Calvin B. Grimes Scholar-in-Residence Program Summer 2019

### The Faculty Resource Network

The sharing of resources among universities and colleges has become a hallmark of institutions striving to achieve new levels of academic excellence. Since 1984, New York University has sponsored the Faculty Resource Network, which now comprises 50 liberal arts institutions working closely with the University in a mutually rewarding partnership.

The central objective of the Faculty Resource Network is to offer faculty from member institutions opportunities to advance their curricular research and professional goals. Through its varied consortial programs, the Network provides a common forum for its members to share their academic pursuits, learn from one another, and develop new perspectives on the issues they confront in teaching and advancing scholarly concerns.

### The Calvin B. Grimes Summer Scholar-in-Residence Program

The Calvin B. Grimes Summer Scholar-in-Residency will be awarded on an annual basis to a faculty member whose project furthers the goal of promoting cross-cultural understanding and tolerance through a closer alignment of the arts and the humanities. Throughout his career, Dr. Grimes championed the importance of expanding the role of the arts in the curriculum, even as performing and fine arts classes would be among the first to fall victim to cutbacks. As he stated,

*The performing arts world is capable of promoting thoughts and ideas on images of reality in other peoples, communities, nations, and world cultures. This is a fundamental trait of great art regardless of medium. It promotes knowledge and understanding of cultures in similar manner to that expressed in literary forms, historical records, philosophical documents, etc. Then, careful attention to the performing arts, not only as sources of immense joy and entertainment, could become an enhanced resource for understanding cultural traditions different from our own. Such a state, it seems, would only promote greater respect for human distinctions. —Dr. Calvin B. Grimes*

Each year, during the month of June, the Calvin B. Grimes Scholar-in-Residence will have the opportunity to engage in research, enrich an existing course or create a new one, develop a musical or artistic work, broaden pedagogical expertise, and expand professional contacts. The awardee will meet with faculty colleagues and fellow artists at New York University and in New York City and will participate in activities scheduled as part of the larger Network Summer program which annually brings over 300

visiting faculty members to NYU's Washington Square campus. In addition to accommodations and most meals, the awardee will receive a travel subvention and an honorarium of \$1,000.

### Prerequisites

Several prerequisites must be met for participation in the Calvin B. Grimes Summer Scholar-in-Residence Program.

1. The applicant must be a full-time faculty member at a member institution of the Faculty Resource Network. A list of current FRN institutions may be found at: <http://www.nyu.edu/frn/membership/member.institutions.html>.
2. The applicant must be approved and recommended by the Provost/Dean of his/her home institution for the term of the residency.
3. The proposed project must exemplify the goal of promoting cross-cultural understanding and tolerance through a closer alignment of the arts and the humanities.
4. New York University must have the resources necessary to be of substantial benefit to the applicant's project goals.

To be considered for this award, applicants must submit to their campus Liaison Officer proposals that describe research or curricular development projects that meet the program prerequisites above. A letter of support from the applicant's division dean and/or department head on campus who is well-acquainted with the applicant's research area must accompany the application, and the application also must be signed by the institutional FRN liaison officer.

### Application Deadlines

#### FOR THE SUMMER 2019 TERM:

Completed applications must be postmarked by **Monday, February 11, 2019**.

Please note: Library access, including borrowing and reading privileges, expire at the end of the academic semester in which the Scholar is accepted into the program. For continued reading privilege access to the NYU libraries beyond the end of the academic semester in which they are Scholars-in-Residence, faculty members should complete and submit the University Associates Program Application (available from our website at <http://www.nyu.edu/frn>, or from their Liaison Officer).
